INVITATION

MARLBORO COUNTY, SC SEEKS THE SERVICES OF A QUALIFIED ARCHITECTURAL/ENGINEERING FIRM TO MANAGE THE DESIGN OF A NEW COMMUNITY AQUATICS FACILITY AT THE MARLBORO COUNTY GOLF AND RECREATION COMPLEX. THE FINAL PRODUCT WILL BE A SELECTION OF A PREFERRED OPTION BY COUNTY COUNCIL AND SUFFICIENT INFORMATION TO FULLY INFORM THE PUBLIC.

THIS WILL BE A TWO-PHASE PROCESS THAT WILL PROVIDE THE COUNTY COUNCIL WITH RENDERINGS AND PLANS FOR A NEW COMMUNITY AQUATICS FACILITY AND LOCKER ROOM/RESTROOM AND OFFICE COMPLEX IN PHASE ONE. ONCE THE PHASE ONE DOCUMENTATION IS REVIEWED BY THE COUNTY COUNCIL AND APPROVED, PHASE TWO WOULD PROVIDE SUFFICIENT DRAWINGS FOR THE CONSTRUCTION OF ELEMENTS IN PHASE ONE.

SUBMITTAL PACKAGES DELIVERED AFTER THE POSTED DEADLINE WILL NOT BE CONSIDERED FOR SELECTION. NO FAXED, TELEPHONE, OR EMAIL PROPOSALS WILL BE ACCEPTED.

PURPOSE

MARLBORO COUNTY GOVERNMENT IS REQUESTING STATEMENT OF QUALIFICATIONS FROM QUALIFIED FIRMS INTERESTED IN PROVIDING PROFESSIONAL SERVICES INCLUDING, BUT NOT LIMITED TO, PRELIMINARY CONSULTATION AND PUBLIC PROCESSES DESIGN SERVICES. IT IS EXPECTED THAT A TEAM FROM SEVERAL CONSULTING SPECIALTIES MAY COLLABORATE ON A PROPOSAL.

PROJECT BACKGROUND

THE MARLBORO COUNTY GOLF AND RECREATION COMPLEX HAS BEEN IN THE CITY OF BENNETTSVILLE FOR OVER 70 YEARS. THE COUNTY RECENTLY PURCHASED THE FACILITY, WHICH INCLUDES AN 18-HOLE GOLF COURSE, TENNIS COURTS, A NON-FUNCTIONING POOL, CLUBHOUSE AND BALLROOM FACILITIES. THE POOL STRUCTURE AND POOL HOUSE ARE WELL BEYOND THE FUNCTIONAL USEFULNESS FOR OPERATIONS AND COUNTY LEADERS ARE SEEKING TO CONSTRUCT A NEW POOL COMPLEX,

RESTROOM FACILITIES AND RECREATION DEPARTMENT OFFICES AT A DIFFERENT LOCATION ON THE PROPERTY.

GOAL

MARLBORO COUNTY SEEKS A COST-SENSITIVE PLAN TO MOVE FORWARD WITH A CAPITAL PROJECT, WHICH ENSURES A SAFE, PLEASANT POOL AND RECREATION FACILITY, IN PLACE BY NO LATER THAN JULY 2024.

ANTICIPATED SCOPE OF WORK

THE SUCCESSFUL CANDIDATE SHALL BE ABLE TO DEMONSTRATE EXPERIENCE AND SKILLS TO COMPLETE THE FOLLOWING TASKS:

PHASE ONE:

- 1. CREATE PLANS TO BUILD A NEW COMMUNITY AQUATICS CENTER WITH THE END RESULT BEING AGREEMENT ON THE BEST OPTION USING COMMUNITY INPUT (HAS ALREADY BEEN COMPLETED)
- 2. DEVELOP CONCEPTUAL DRAWING AT A SUFFICIENT LEVEL OF DETAIL TO SUPPORT PUBLIC INFORMATION EFFORTS IN SUPPORT OF THE PUBLIC PLANNING PROCESS.
- 3. DEVELOP AND RECOMMEND A SPECIFIC FINANCIAL PLAN FOR THE PROJECT USING BLENDED SOURCES OF FUNDING, TO INCLUDE FEDERAL ARP FUNDS, STATE RECREATION GRANT, CAPITAL BUDGET APPROPRIATION, PRIVATE FOUNDATION GRANTS, OTHER UNANTICIPATED SOURCES.

PHASE TWO (AFTER COUNCIL APPROVAL OF PHASE ONE):

1. PROVIDE SUFFICIENT DRAWINGS FOR THE CONSTRUCTION OF ONE OR MORE OF THE ELEMENTS IDENTIFIED IN PHASE ONE.

THERE WILL BE A NON-MANDATORY PRE RFQ SUBMITTAL MEETING AND SUBSEQUENT WALKTHROUGH AT THE

MARLBORO COUNTY GOLF AND RECREATION COMPLEX. CALL TO ARRANGE MEETING.

DELIVERABLES AND SCHEDULE

MANAGE A PUBLIC INVOLVEMENT PROCESS WITH THE GOAL TO CREATE PLANS TO BUILD A NEW COMMUNITY AQUATICS FACILITY WITH THE END RESULT BEING AGREEMENT ON THE BEST OPTION, PRELIMINARY DESIGN, AND A PUBLIC INFORMATION STRATEGY.

THE COUNTY WILL WORK WITH THE CHOSEN FIRM TO DEVELOP A TIMELINE WITH CLEAR DECISION POINTS FOR THE ELEMENTS/PHASES OF THIS CONTRACT.

SELECTION PROCESS

STAFF WILL REVIEW THE QUALIFICATION PACKAGES RECEIVED, BASED ON THE EVALUATION CRITERIA ESTABLISHED BELOW, TO ARRIVE AT A SHORTLIST FOR AN INTERVIEW. AN INTERVIEW PANEL WILL REVIEW PROPOSALS AND INTERVIEW

APPLICANT TEAMS. SHORT-LISTED CONSULTANT TEAMS WILL BE RANKED AFTER THE INTERVIEW AND A RECOMMENDATION MADE TO THE COUNTY COUNCIL. THE COUNTY MAY CHOOSE TO CONTACT OFFICIALS FROM OTHER JURISDICTIONS REGARDING THE CONSULTANT, THEIR PRIOR WORK EXPERIENCE, AND THEIR ABILITY TO SUCCESSFULLY COMPLETE THE SCOPE OF SERVICES. THE COUNTY MAY REQUIRE CHANGES IN THE SCOPE OF SERVICES AS DEEMED NECESSARY BY THE COUNTY, BEFORE EXECUTION OF THE CONTRACT. THE COUNTY INTENDS TO ENTER INTO AN AGREEMENT WITH THE CONSULTANT TEAM WHO PROVIDES A PROPOSAL THAT, IN THE OPINION OF THE COUNTY, BEST MEETS ALL OF THE BELOW LISTED EVALUATION CRITERIA AS DETERMINED BY THE COUNTIES' SELECTION COMMITTEE AND RANKS THE HIGHEST IN THE INTERVIEW. THE DIRECTOR OF THE GOLF & RECREATION COMPLEX WILL SUBMIT A FINAL RECOMMENDATION TO THE COUNTY ADMINISTRATOR AND THE COUNTY COUNCIL FOR APPROVAL. UPON SELECTION OF A CONSULTANT, THE COUNTY INTENDS TO ENTER INTO AN AGREEMENT USING THE STANDARD AIA SERVICES AGREEMENT AS MODIFIED FOR SOUTH CAROLINA GOVERNMENT REQUIREMENTS.

- 3. INCLUDE RESUMES FOR ALL KEY PERSONNEL AND INDICATE ANY INDIVIDUALS WHO HAVE HAD PREVIOUS EXPERIENCE ON SIMILAR PROJECTS.
- 4. Provide a proposed project schedule.
