I. PURPOSE / SUMMARY:

- Develops and implements both short and long-range economic development plans and strategies.
- Sets and implements an annual program of action.
- Accept gifts and grants of money from either private or public sources to be used to promote economic development in the County. Provided however, that matching requirements and gifts of real estate must receive prior approval by County Council and all monies shall be accounted for in the same manner as funds appropriated by County Council.
- Cooperates with any federal, state, local agency, board or commission in the furtherance of its purposes.
- Cooperates with any interested private concern, civic organization or subdivision thereof in furtherance of its purposes.
- Presents a Periodic Report to the County Council. It shall include subjects and recommendations for the improvement and advancement of the economic welfare of the citizens of Marlboro County.
